RELEASE OF LIABILITY, INDEMNIFICATION, AND PERMISSION FORM

In consideration of Maranatha Bible Church offering and organizing Maranatha Preschool Park (ages 3-5) from September 1, 2012 to May 31, 2013, I on behalf of myself, my child, my spouse, my personal representatives, relatives, heirs and assigns, hereby voluntarily agree to release, waive, forever discharge, hold harmless, defend, and indemnify Maranatha Preschool Park and Maranatha Bible Church, and its volunteers, members, agents, officers, elders, and employees (hereinafter collectively referred to as "Maranatha Preschool Park") from any and all claims, actions, causes of action, damages, expenses or losses for bodily injury, property damage, wrongful death, loss of services and consortium, or any other loss or damage of any kind whatsoever, which may arise out of my child's participation in Maranatha Preschool Park. I fully understand and acknowledge that (a) risks and dangers exist in the child's participation in Maranatha Preschool Park; (b) the child's participation in Maranatha Preschool Park may result in injury or illness; (c) these risks and dangers may be caused by the negligence of the volunteers, members, employees, officers, or agents of Maranatha Preschool Park and Maranatha Bible Church, the negligence of the participants, the negligence of others, accidents, or other causes; and (d) these risks and dangers may arise from foreseeable or unforeseeable causes, hazards, and dangers.

I hereby represent that my child is in good health and has no known physical disabilities or health problems that will present any risk to his/her participation in Maranatha Preschool Park. By signing below, I grant permission for my child to fully participate in Maranatha Preschool Park and I, on behalf of myself, my child, my spouse, my personal representatives, relatives, heirs and assigns, assume all risks associated with the child's participation in Maranatha Preschool Park, including any transportation to and from Maranatha Preschool Park. Also, by signing below, I hereby authorize Maranatha Preschool Park or any of its agents, members or employees, where Maranatha Preschool Park is unable to contact me, to give my child emergency medical treatment and to determine the need for additional emergency medical treatment and/or to obtain emergency medical treatment, including transportation by ambulance to an emergency medical facility for the child. I also understand and agree that Maranatha Preschool Park carries coordinated accident insurance, which is secondary to my insurance, and it is my responsibility to submit all medical bills incurred by or on behalf of the child to my personal insurance company for payment. I also give permission for photographs or video footage of my child to be used by Maranatha Preschool Park for display or promotional purposes.

I HAVE READ THE ABOVE AND BY SIGNING IT I AGREE THAT IT IS MY INTENTION TO GRANT PERMISSION FOR MY CHILD TO PARTICIPATE IN MARANATHA PRESCHOOL PARK AND ITS ASSOCIATED ACTIVITIES AND TO ASSUME AND ACCEPT ALL RISKS AND LIABILITIES ASSOCIATED THEREWITH.
